KNOW ALL MEN BY THESE PRESENTS:

THAT WE, Centric Fiber, LLC & Hooks Gas Pipeline, whose (address, phone) is 9950 Woodloch Forest Drive, Suite 2400, The Woodlands, Texas, (281-252-6700), hereinafter called the Principal, and Capitol Indemnity Corporation, a Corporation existing under and by virtue of the laws of the state of Wisconsin and authorized to do an indemnifying business in the state of Texas, and whose principal office is located at (name/address/phone) P.O. 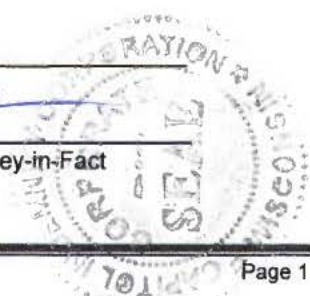




Any such appointment may be revoked, for cause, or without cause, by any of said officers, at any time.”


In connection with obligations in favor of the Florida Department of Transportation only, it is agreed that the power and authority hereby given to the Attorney-in-Fact includes any and all consents for the release of retained percentages and/or final estimates on engineering and construction contracts required by the State of Florida Department of Transportation. It is fully understood that consenting to the State of Florida Department of Transportation making payment of the final estimate to the Contractor and/or its assignee, shall not relieve this surety company of any of its obligations under its bond.

In connection with obligations in favor of the Kentucky Department of Highways only, it is agreed that the power and authority hereby given to the Attorney-in-Fact cannot be modified or revoked unless prior written personal notice of such intent has been given to the Commissioner – Department of Highways of the Commonwealth of Kentucky at least thirty (30) days prior to the modification or revocation.


