AMENDMENT AND RATIFICATION OF PAID-UP OIL, GAS AND MINERAL LEASE (RFP 20-084)

WHEREAS, reference is made herein and made a part hereof for all purposes to that certain Paid-Up Oil, Gas and Mineral Lease dated June 15, 2020, by and between FORT BEND COUNTY (“Lessor”), and HALEX OIL CORPORATION (“Lessee”), recorded as Instrument No. 2022020568 in the Official Public Records of Fort Bend County (the “Lease”); and

WHEREAS, paragraph no. 2 of the Lease provides for a primary term of three (3) years; and

WHEREAS, Lessor and Lessee desire to amend paragraph no. 2 of the Lease to provide for a primary term to five (5) years.

NOW THEREFORE, in consideration of the premises and the mutual benefits to be derived therefrom, the receipt and sufficiency of which are hereby acknowledged, the undersigned, being the respective Lessor and Lessee under the Lease, do hereby amend paragraph no. 2 of the Lease to read as follows:

2. Subject to the other provisions herein contained, this lease shall remain in force for a term of Five (5) YEARS (called “primary term”), and as long thereafter as oil, gas or other mineral is produced from said physical land or land with which said land or any part thereof is pooled, or this lease is maintained by virtue of some other provision hereof.

As hereby amended, the Lease shall remain in full force and effect in accordance with its terms and provisions and the undersigned do hereby fully ratify and confirm the Lease as hereby amended.

This Amendment and Ratification of Paid-Up Oil, Gas and Mineral Lease shall extend to and bind the undersigned and their respective successors, heirs and assigns.

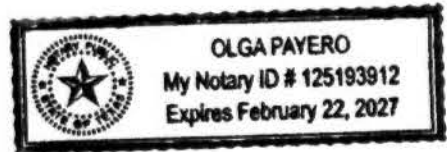

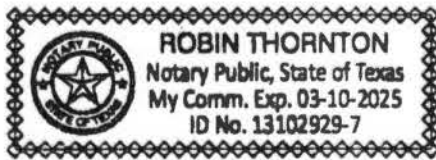
