Ryan Dunsmore, Project Manager – Multimedia Communications presented several Community Shoutouts.

Tami Frazier, Communications Director for the Office of the County Judge presented three Proclamations, on behalf of Commissioners Court to:

- Texana Center, George Patterson, CEO, Shena Ureste, Director of Behavioral Healthcare Services, Cherie Steinberg, Crisis Services Manager and Amber Edison, Assertive Community Treatment SB 292 Leader during Mental Health Awareness Month. Texana Center is commended for continuing their work in the mental health field.
- Daphne Colbert during National Teachers Appreciation Week. Ms. Colbert is currently a teacher at LCISD Fort Bend County Alternative School and is commended for her efforts in positively shaping the young minds of Fort Bend County.

Mr. Oli Mohammed, Houston Furniture Bank announced there will be another distribution of furniture and mattresses that will be provided to families in need. This distribution will be on June 3 in Fort Bend County to at least 200 – 300 families. Mr. Mohammed stated the goal is that no child in our community should sleep on the floor.

She thanked the court for the years of support to continue the work of helping our kids with a home for today and hope for tomorrow.
