**SIXTH AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS SIXTH AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and Amani Engineering, Inc., (hereinafter “Contractor”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on October 6, 2015, (hereinafter “Agreement”) pursuant to SOQ 14-025, as amended by documents dated April 26, 2016 (hereinafter “Amendment”), September 6, 2016 (hereinafter “Second Amendment”), November 27, 2018, (hereinafter “Third Amendment”), and June 8, 2021 (hereinafter “Fourth Amendment”) March 22, 2022 (hereinafter “Fifth Amendment”); and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional one hundred seven thousand five hundred sixty-six dollars and 25/100 (\$107,566.25) to perform the additional engineering and surveying services as described in Contractor’s Fee Proposal dated March 27, 2023 attached hereto as Exhibit “A” and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed eight hundred seven thousand forty dollars and 75/100 (\$807,040.75), for the entire contract amount; authorized as follows:
 - \$425,286.00 under the Agreement;
 - \$36,555.00 under the Amendment;
 - \$75,240.00 under the Second Amendment;
 - \$56,984.00 under the Third Amendment;
 - \$70,749.50 under the Fourth Amendment;
 - \$34,660.00 under the Fifth Amendment; and
 - \$107,566.25 under this Sixth Amendment

3. In no case shall the amount paid by County for all Services under the Agreement and any subsequent amendment exceed the Maximum Compensation without an agreement executed by the parties.
4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement and the subsequent amendments shall remain unchanged.



Reference is made to e-mail dated January 11, 2023 and subsequent TEAMS conversation on January 19, 2023, wherein we discussed the County's desire to modify/revise the drainage design along South Post Oak, south of West Sycamore, adding a left turn lane, and modifications to the traffic signal at the intersection of South Post Oak and Trammel Fresno. Amani is pleased to provide this fee proposal for these additional engineering services for the referenced project. The scope of work, exclusions, deliverables, schedule and proposed fee is as follows:

Scope of Work

- Revise drainage design south of West Sycamore to discharge into the storm system along West Sycamore begin designed by others and eliminate the proposed detention pond at the southwest corner.
- Add a left turn lane for a proposed park at the southwest corner of South Post Oak and West Sycamore intersection.
- Revise the intersection design to include West Sycamore ultimate configuration at South Post Oak.
- Modifications of the existing traffic signal at the intersection of South Post Oak and Trammel Fresno to eliminate conflicts with proposed roadway improvements.
- Update topographic survey at the intersection of South Post Oak and Trammel Fresno.
- Update utilities information for the entire project limits.
- Revise typical sections, details, TCP and SWPPP as required based on the design changes.
- Update proposed bid quantities and engineer's estimate of probable construction cost.

Exclusions

- All work not referenced in the above Scope of Work section.

Deliverables

- Updated plan & profile drawings and detail sheets required to adequately present the revised pavement and water line relocation design.
- Updated bid quantities and estimate of probable construction cost.

CivilCorp, LLC is pleased to submit this fee proposal for surveying services for the above referenced project. Survey shall conform to Fort Bend County Engineering Design Manual, August 2020 edition. We propose the following scope of work, deliverables, schedule, fee and exclusions for our services.

I. SCOPE OF WORK

TOPOGRAPHIC SURVEY

The topographic survey shall be at the intersection of Trammel Fresno Road and South Post Oak Boulevard, extending 200' East and West along Trammel Fresno, and 200' South and 50' North along South Post Oak Boulevard. The topographic survey will be within the existing right-of-way. The survey is to include edge of pavements, driveways, signs, mailboxes, traffic signals, sidewalks, pavements markings, etc. Pavement material types will be indicated as determined on the surface. Cross sections of the project area will be taken at intervals not to exceed 100 feet. All data will be added to the existing topographic file.

Digital Terrain Model

The existing three dimensional surface model or DTM will be updated with relevant cross section and point data obtained in the topographic survey.

RIGHT-OF-WAY VERIFICATION

The existing right-of-way at Trammel Fresno and South Post Oak Boulevard shall be reviewed to determine if any changes to the right-of-way have occurred since the previous survey. Any updates shall be made to the existing right-of-way file.

UTILITY FILE UPDATE

CivilCorp will place a Texas 811 one call for the project limits. All above ground utilities, marked underground utilities will be tied and downhole information of manholes will be obtained to supplement the previous survey performed. This scope does not include any SUE level A-D or marking underground utilities by CivilCorp.

II. FEE

The estimated fee for the above mentioned Scope of Work for lump sum payment is **\$ 19,566.25**

Deliverables

1. Copy of ASCII Points in .txt format
2. All updated CAD files including DTM in AutoCAD format

Schedule

Deliverables will be sent within 8 weeks once notice to proceed is given.

Exclusions

1. Resetting disturbed or missing iron rods from previous survey
2. Subsurface utility engineering and locating
3. Right of Entry agreements
4. Extra work that is not included in our Scope of Work.
