SECOND AMENDMENT TO ADDENDUM TO LEGAL SERVICES AGREEMENT

THIS SECOND AMENDMENT TO ADDENDUM TO LEGAL SERVICES AGREEMENT (the "Second Amendment") is entered into by and between Fort Bend County, (hereinafter the "County"), a body corporate and politic under the laws of the State of Texas, and Cokinos | Young (hereinafter the "Firm"), a law firm authorized to conduct business in the State of Texas. The County and the Firm may be individually referred to as a "Party" or collectively as the "Parties".

WHEREAS, the Parties executed and accepted that certain Addendum to Legal Services Agreement on June 14, 2022 for matters related to the Chimney Rock Road Mobility Project No. 17202, and the Amendment to Addendum to Legal Services Agreement on or about December 6, 2022 (collectively the "Agreement"); and

WHEREAS, the Parties desire to amend the Agreement to increase the Maximum Compensation payable to the Firm by the County for services to be performed under the Agreement.

NOW, THEREFORE, the Parties do mutually agree as follows:

1. The County shall pay the Firm an additional amount not to exceed two hundred fifty thousand dollars and no/100 (\$250,000.00) to perform additional services under the Agreement.
2. The Maximum Compensation payable to the Firm for all services to be rendered under the Agreement is hereby increased to an amount not to exceed three hundred seventy-five thousand dollars and no/100 (\$375,000.00), authorized as follows:
 \$125,000.00 under the Agreement; and
 \$250,000.00 under this Second Amendment.
3. In no case shall the amount paid by the County for all services under the Agreement and this Second Amendment exceed the Maximum Compensation without further written agreement executed by the Parties.
4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

IN WITNESS WHEREOF, the parties have executed this Agreement and caused this Agreement to be effective on the date executed by County.
