## Power of Attorney

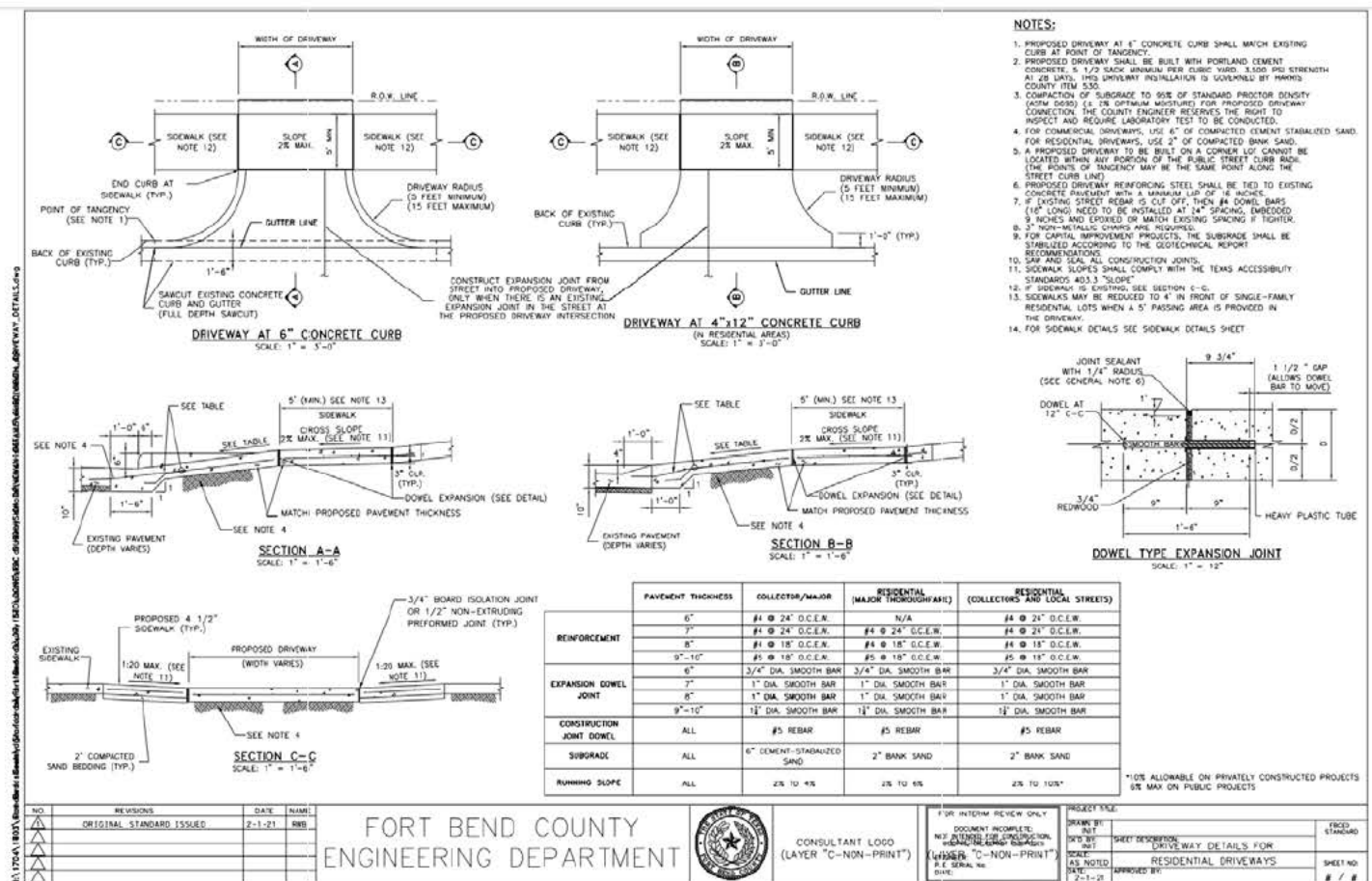
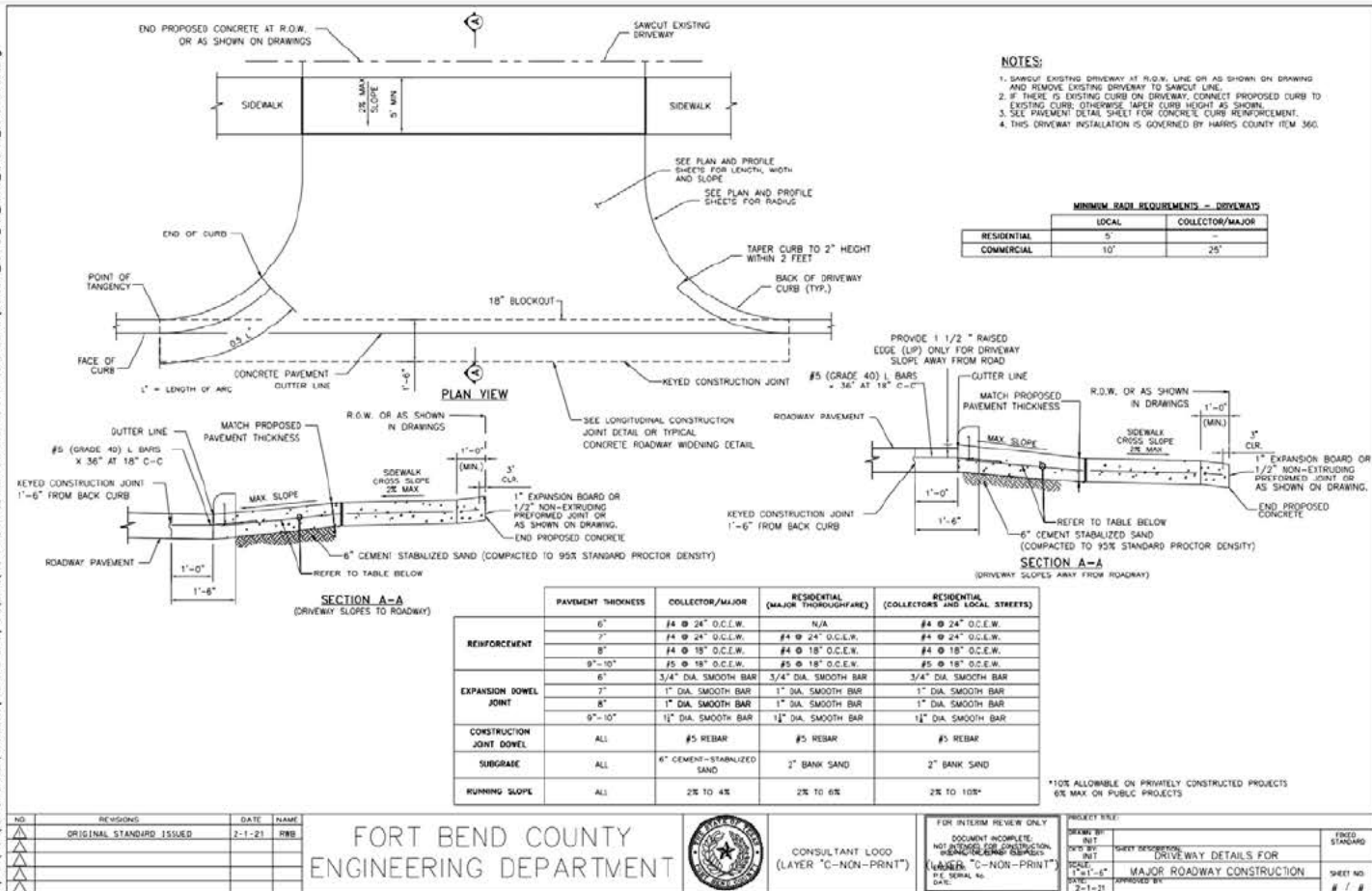
