THIRD AMENDMENT TO FORT BEND COUNTY TAX ASSESSOR-COLLECTOR CREDIT CARD PROCESSING SERVICES AGREEMENT RFP 19-023

THIS THIRD AMENDMENT (the "Third Amendment") is made and entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Grant Street Group, (hereinafter "Contractor") a company authorized to conduct business in the State of Texas.

WITNESSETH

WHEREAS, County and Contractor executed the Agreement for Credit Card Processing Services on or about July 23, 2019, and as renewed on or about July 6, 2021 and August 2, 2022 (collectively the "Agreement"), and incorporated fully by reference as if set forth herein verbatim. County and Contractor desire to amend said Agreement as set forth below:

- A. The Agreement is hereby renewed; effective July 23, 2023 and shall terminate on July 22, 2024. Any references to Attachment 2 of the Agreement (GSG Charges) are hereby deleted and replaced with the Revised Attachment 2 (GSG Charges), attached as Exhibit "I" and incorporated fully by reference.
- B. If there is a conflict among documents, the most recently executed document will prevail with regard to the conflict.
- C. Human Trafficking. BY ACCEPTANCE OF CONTRACT, CONTRACTOR ACKNOWLEDGES THAT FORT BEND COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.
- D. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
