1. Call to Order.

Call to Order by Judge KP George at 10:02 a.m.

2. WORKSHOP:

A. Conduct workshop to discuss and take all appropriate action to approve project list for Mobility Bond referendum for the November 7, 2023, election.

Ed Sturdivant, County Auditor provided the court with information and direction on the proposed Mobility and Parks Bond Referendum for the November election. The total amount for mobility projects is \$800 million and parks projects total is \$147 million. The number of years to complete these projects could take 15 years. Mr. Sturdivant suggested the court determine a number for the bond and how to schedule out the projects to the taxpayers with possible subsequent bond referendums. With the guidance of Engineering, the court could decide the highest priority of projects on the list. The court will be able to do everything they need to do to take care of this community, within the limit of the tax rate limit. The court needs to demonstrate to the taxpayers the County is doing what is most prudent to benefit the taxpayer.

There was discussion among the court for a recommended amount to place on the Mobility Bond Referendum. An amount between \$400 - \$600 million has been suggested.

Item 2 continued - Workshop:

B. Conduct workshop to discuss and take all appropriate action to approve project list for Parks Bond referendum for the November 7, 2023, election.

There was discussion among the court to determine a recommended amount to place on the Parks Bond Referendum. An amount of \$150 million has been suggested.

C. Conduct workshop to discuss and take all appropriate action on results from Needs Assessment Study to consider the following:

Option 1: Construction of a new animal shelter on a new site that serves the current service of the unincorporated areas of the County.

Option 2: Construction of a new regional animal shelter on a new site to serve the current service area described in Option 1, plus the Cities of Missouri City, Rosenberg, Stafford and Sugar Land if they elect to participate.
