**ORDER APPOINTING DIRECTORS FOR  
FORT BEND COUNTY LEVEE IMPROVEMENT DISTRICT NO. 6**

WHEREAS, the Texas Water Code, Chapter 57, Subchapter C; has established that Commissioners Court is responsible for the appointment and removal of Directors for Levee Improvement Districts ("LID") created by the Court;

WHEREAS, the Texas Water Code, Chapter 57, Subchapter C; also establishes that Commissioners Court is responsible for filing any vacancies of a LID in the Board of Directors;

WHEREAS, the Commissioners Court of Fort Bend County, Texas ("Court"), previously appointed Linda Anne Jacks and Kent Savage as Directors on the Board for Fort Bend County Levee Improvement District No. 6 (the "District").

WHEREAS, the District has one vacancy on the Board and the Commissioners Court seeks to appoint the following individual as a Director for the current unexpired term on the Board;

Director	Term
Patrick Nguyen	June 5, 2023 through June 5, 2027

WHEREAS, in accordance with the Texas Water Code, Section 57.051(b), the District has a population of more than 2,000 residents and the Commissioners Court desires to increase the composition of the Board to five (5) members;

WHEREAS, Commissioners Court's decision to expand the number of directors on the Board from three to five; results in two additional vacancies to be filled by this Order Appointing Directors as follows:

Director	Term
A. Ali Khan	August 22, 2023 through August 22, 2027
David Vrshek	August 22, 2023 through August 22, 2027

WHEREAS, Commissioners Court finds that all five of the Directors named herein are over twenty-one years of age, resident citizens of the State of Texas, are qualified by law to serve as a District Directors, and are not disqualified from serving by reason of any law; and

WHEREAS, Commissioners Court also finds that the Directors Nguyen, Khan and Vrshek are tax paying residents of the District and meet the Court requirements in the ORDER ESTABLISHING THE MINIMUM QUALIFICATIONS FOR COMMISSIONERS COURT LEVEE IMPROVEMENT DISTRICT DIRECTOR APPOINTEES UNDER THE TEXAS WATER CODE last revised and adopted in November 2019.

NOW THEREFORE, IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED BY THE COUNTY JUDGE AND COURT OF FORT BEND COUNTY, TEXAS THAT:

Section 1: The foregoing recitals are hereby found to be true and correct.

Section 2: The following individuals the five individuals named herein are hereby appointed as Directors of Fort Bend County Levee Improvement District No. 6 to serve in that capacity for a four year term of office, or until his or her successor shall be appointed and qualified; as identified in this Order of Commissioners Court.

Section 3: A copy of the Order shall be recorded in the minutes of this Court.
