Ed Sturdivant, County Auditor explained this resolution is the first step for the County to authorize the execution of documents as listed on the Agenda item for the issuance of lease revenue bonds and the documents required for the construction of a Sheriff's Office Training Facility Complex at our Fairgrounds.

Commissioner Meyers stated when the County normally issues debt, we ask the voters for permission. This agreement is for \$110 million.

Commissioner McCoy stated he is uncomfortable moving forward without a feasibility study.

Sheriff Fagan explained the team working on this complex went to other Counties to look at their shooting range. The purpose of this shooting range is to have Fort Bend County law enforcement better prepared for situations that may come up in the future. The legislature passed a bill for all Texas Peace Officers to have 16 hours in active shooter training. This building is not just for the County but for agencies around the County. These agencies and private industries will have to pay to use the facility.

Kevin Matocha, Stonehenge Holdings CEO, stated this plan has been condensed from what was initially proposed and contains all components required for the certification program. In looking at the current growth and the way training is performed today, the ability to have one facility will be more efficient. This facility is proposed to be on County property, which will not require land acquisition.

Mr. Sturdivant explained the delivery model of the EpiCenter has demonstrated there are potential costs savings by using the P3 Delivery model. This same model is proposed for this facility. The statute does provide the authority of this court to do this without going to the voters. The court has collectively determined this is a priority that needs to be addressed.

Bridgette Smith-Lawson, County Attorney stated the Public Private Partnership, P3 model is a legitimate legal tool the County has as a resource to fund these projects. An outside council is available to provide an analysis and go over the step-by-step process.

Pamela Gubbels, Director of Finance & Investments summarized the budget. The total FY2024 Budget is \$767,159,901 which is a 35 percent increase over the FY2023 Budget. The majority of this increase is due to two items. First, Employee Benefits and Other Self Funded Insurance are managed in internal service funds as prescribed by GASB. Historically, these funds have not been budgeted since they result in an allocation from the County's operating budget. As a controlled procedure for improvement, these funds have been budgeted to insure compliance with LGC 111 at the account level rather than monitoring accounts at the appropriation level. A \$57 million allocation for insurance benefits is budgeted in the departmental budget as well as a \$57 million expense in the internal service funds. These two funds shows a large increase in this year's budget. Second, the OPEB Trust Allocation is being funded with excess M&O rate over the Voter Approval Rate. In 2023, the County funded \$20 million and in FY2024 Budget, a \$25 million allocation has been included. This excess rate is moved to the I&S or debt service with the approval of Commissioners Court in the adopted budget and tax which was just approved. This is a fiscally prudent approach to addressing the County's OPEB liability currently estimated at \$480 million.

Ms. Gubbels recommended a change to the budget. She requested to move \$116,339 from the Public Defender Budget into the County Attorney's Budget for an investigator.

Commissioner Morales stated, for the record, the following: First, I want to agree with what Commissioner Meyers said at Monday's public hearing. There has definitely been some public confusion about the County budget because portions of the budget look different and some reports have been misleading. The County Auditor and Budget Officer adopted recommended accounting practices for FY2024 that are new to our annual process. I think the OPEB item in particular was a difficult topic to explain, and I want to publicly thank the staff for taking time to publicly clarify much of the confusion.

I also appreciate and respect how the citizens of Fort Bend have put true effort into education and understanding in this budget process. Many people saw these changes and were right to step up and seek answers. As a Commissioner's Court, this feedback keeps us more responsive and more transparent during an important process that impacts all taxpayers.

Item 27 continued - Budget & Finance:

This is our most important time to work and plan ahead. This is a fast-growing County - by multiple metrics. Revenues jumped this past year from multiple growth sectors. So much of this County's growth and new value comes from Precinct 1, and Lord willing, that growth seems destined to continue for many years to come.

To echo what Commissioner Meyers says every year – this Fort Bend County budget is another consecutive year – in a very LONG string of years – where we are lowering the County's tax rate. I've said it before, but it bears repeating – Fort Bend will always be different from almost all the other Counties in Texas because of our huge unincorporated population. We work hard to provide reliable and valuable County services in Fort Bend because most of our residents don't live inside the city limits. Although we will never have a per capita employee rate equal to the cities in Fort Bend County, I believe that our citizens have moved here because they trust our long-time County service model, and because they trust us to protect their tax dollars. That's my focus, and that's what we are working to accomplish every day in the new Precinct 1.

Finally, to the employees of the County - I want you to know that I'm here to support and uphold the obligation to our people to do what we can, in a financially responsible way, to try and help offset inflation with a COLA adjustment. The federal government is literally devaluing the wealth and savings of our citizens by actions and decision making that has led to rampant inflation. We can't undo all of that damage, but I do believe that we can do something. That's why this budget mirrors what the Texas Legislature mandated for state employees over the biennium. We are following the example of our Republican state legislators. We are grateful to serve, and grateful for the support of our residents as we work to maintain our quality of life in the Precinct 1 community.

Commissioner Meyers mentioned there is another revenue source, sales tax revenue, which now totals about \$28 million a year. This revenue source could help with our budget and property tax rate.

Judge George summarized what this Budget offers. The County delivers the best services to our citizens who live in the unincorporated areas of the County, we successfully battled a pandemic, there is a cost to do business which means we are paying County employees a competitive salary and the County continues to attract people to move to Fort Bend County. The court has continued to do an excellent job in serving the citizens of the County along with being mindful of our citizens tax dollars.

Commissioner McCoy underscored the taxes paid to the County is the smallest portion on the taxpayer's bill. The FY2024 Budget includes a \$25 million contribution to OPEB Trust, provides personnel to improve the safety of the County's unincorporated areas, provides services during this time when costs have increased, meets the needs of new residents coming to this County every year, makes investments in public health to be informed of illnesses and makes improvements in traffic. The County is in a healthy financial situation such that the County can make such an investment in Capital Improvements and still cut the County tax rate.
