COMMERCIAL	10'	25'



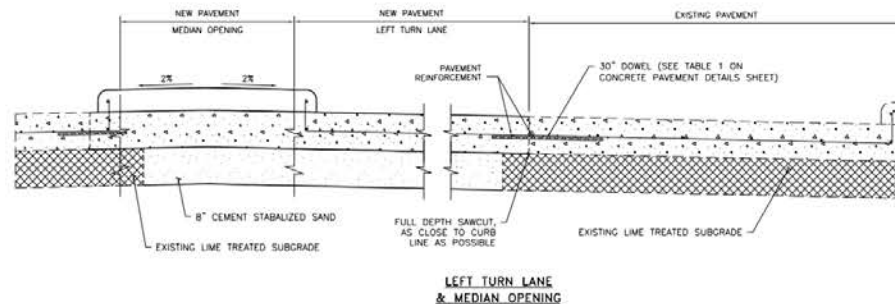
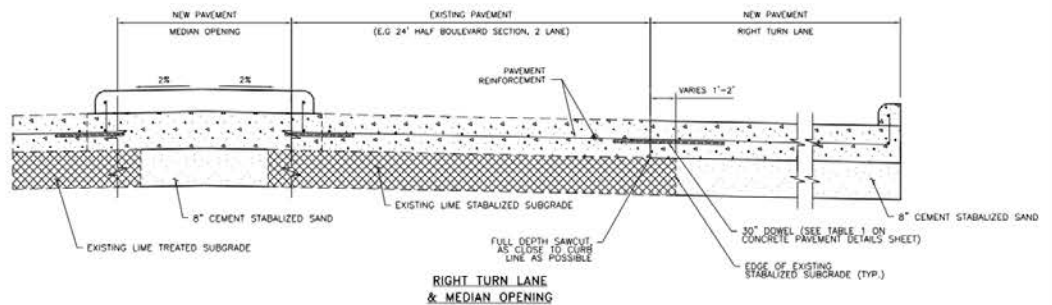
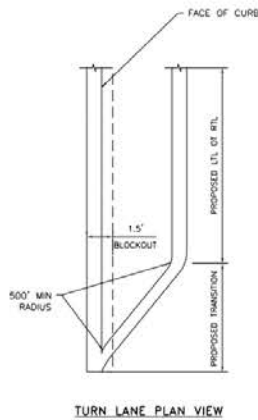
