Fort Bend County Engineering Department has received and reviewed a request (letter attached) from Blackline Engineering on behalf of Houston LD, LLC., for Fort Bend County to sponsor a project for a public road connection for Esperanza Terrace Drive at FM 361. The road connection will provide the primary point of access for the Esperanza development.
