Power of Attorney

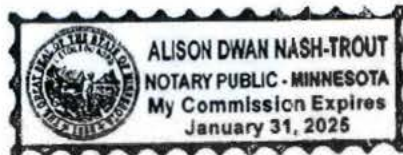
