AMENDMENT TO AGREEMENT FOR PROFESSIONAL FIELD ENGINEERING SERVICES

THIS AMENDMENT (“Amendment”) is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and Lonestar Program Controls Group, (hereinafter “Consultant”), a company authorized to conduct business in the State of Texas (collectively referred to as the “parties”).

WHEREAS, the parties executed and accepted that certain Agreement for Professional Field Engineering Services on July 5, 2022, (hereinafter “Agreement”) pursuant to SOQ 14-025, and incorporated fully by reference; and

WHEREAS, the parties desire to amend the Agreement for additional professional field engineering services to be provided and increase the total Maximum Compensation for such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Consultant an additional Nine Hundred Eighty-Two Thousand, Eight Hundred dollars and 00/100 (\$982,800.00) for the additional professional field engineering services as described in Consultant’s proposal dated July 17, 2023, attached hereto as Exhibit “A” and incorporated herein for all purposes.
2. The Maximum Compensation payable to Consultant for Services rendered is hereby increased to an amount not to exceed One Million, Four Hundred Sixty-Seven Thousand, Nine Hundred dollars and 00/100 (\$1,467,900.00), authorized as follows:
 \$485,100.00 under the Agreement; and
 \$982,800.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further written agreement executed by the parties.
4. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.


