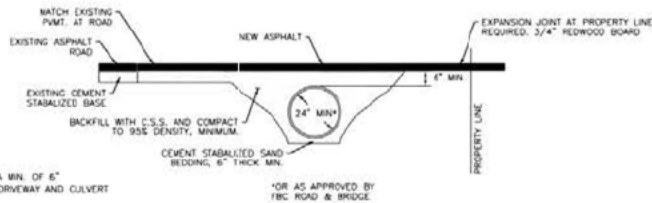




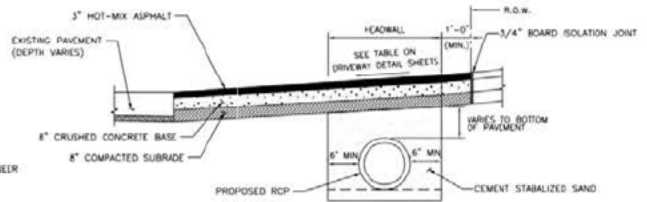
OPEN DITCH DRIVEWAY

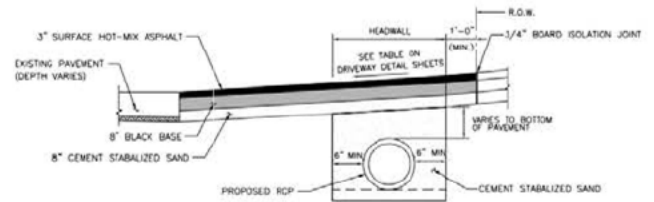

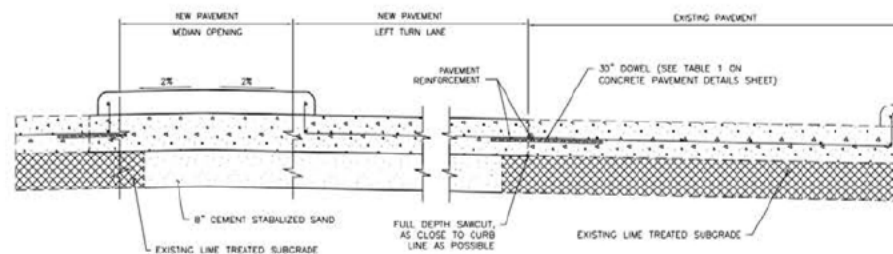
