Take all appropriate action on Interlocal Agreement for Additional Law Enforcement Services between Fort Bend County and Fort Bend County Assistance District No. 11 with services to be provided by the Office of Constable Precinct 1; for six (6) contract deputies to which payment will be split equally among the participating districts (i.e. nineteen percent between County Assistance District Nos. 1, 7, 9, 10 and 11), effective through September 30, 2024.
