Justin Jurek, Fire Marshal updated the court on the drought situation. On August 8, 2023, a Burn Ban was enacted in the County. On Friday, October 6, the Burn Ban was lifted at 1:00 p.m.

Commissioner Meyers announced on August 20, 2023, Governor Abbott called for the establishment of the Texas Advanced Nuclear Reactor Working Group to provide Texans with safe, reliable, clean and affordable energy for our future.
