

KNOW ALL MEN BY THESE PRESENTS:

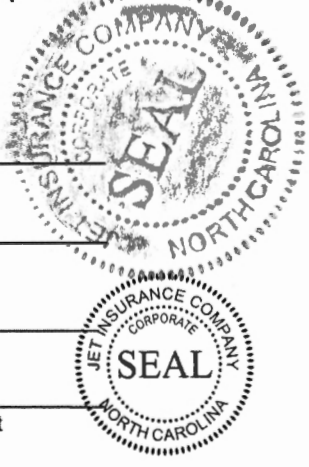
This bond is payable at the County Courthouse in the County of Fort Bend and State of Texas.

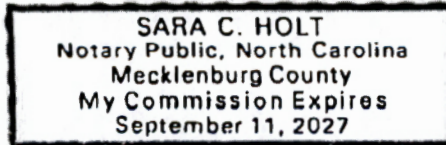
