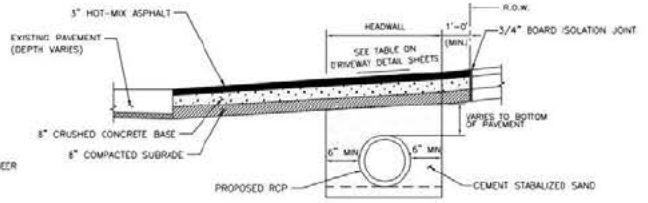


OPEN DITCH DRIVEWAY

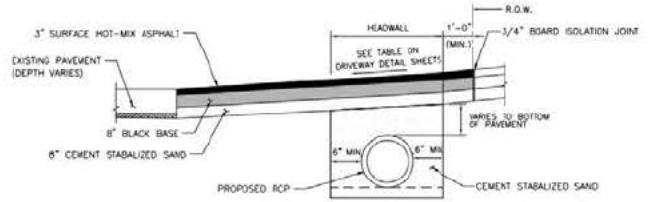

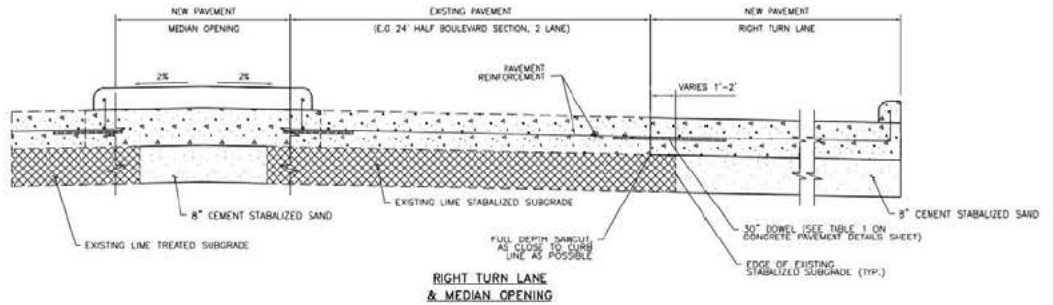

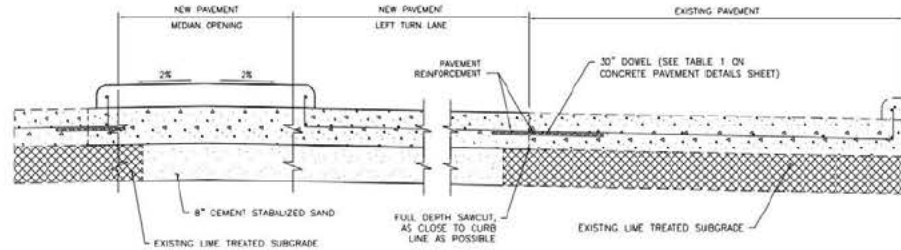
