AMENDMENT TO AGREEMENT FOR ENGINEERING INSPECTION SERVICES

THIS AMENDMENT is made and entered into by and between Fort Bend County, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and HJ Consulting, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Engineering Inspection Services on April 27, 2021, (hereinafter referred to as the "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to allow Contractor to provide additional Services under the Agreement and increase the maximum compensation amount.

NOW, THEREFORE, the parties do mutually agree as follows:

1. Contractor shall render the Engineering Inspection Services, as described Contractor's proposal attached hereto as Exhibit A, and incorporated herein for all purposes.
2. County shall pay Consultant an additional amount not to exceed four hundred forty-six thousand five hundred seventy-one dollars and 60/100 (\$446,571.60) to perform the additional Services, as described in Consultant's proposal attached hereto as Exhibit "A" and incorporated herein for all purposes.
3. The Maximum Compensation payable to Consultant for all Services rendered is hereby increased to an amount not to exceed six hundred fifty-one thousand nine hundred fifty-four dollars and 0/100 (\$651,954.00), authorized as follows:

\$205,382.40 under the Agreement; and

\$446,571.60 under the Amendment.

4. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.

5. The parties hereby agree the Time of Performance under the Agreement shall end no later than December 31, 2026.

6. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.




