

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, Tejas Underground Utilities, L.L.C., whose (address, phone) is P. O. 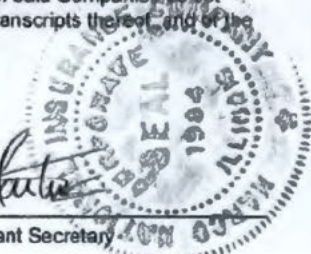
