RENEWAL

1. Term

This Renewal is effective beginning December 1, 2023 and will expire on November 30, 2024.

2. Effect of Renewal

Except as expressed herein, the terms of the Agreement remain in full force and effect. If there is a conflict between this Renewal and the Agreement, the provisions of this Renewal shall prevail. This Renewal shall be effective upon execution by the County.
