SECOND AMENDMENT TO PROJECT MANAGEMENT AGREEMENT FOR THE 2017 FORT BEND COUNTY MOBILITY BOND PROGRAM

THIS SECOND AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and LJA ENGINEERING, INC., (hereinafter "Project Manager"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Project Management Agreement for the 2017 Fort Bend County Mobility Bond Program on March 13, 2018, which was subsequently amended on March 23, 2021, (hereinafter collectively referred to as the "Agreement"); and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation under the Agreement, and to extend the time of performance for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. County shall pay Project Manager an additional five hundred thirty-four thousand dollars and 00/100 (\$534,000.00), for the Services as described in Project Manager's Proposal for Additional Services dated September 21, 2023, attached hereto as Exhibit "A-2 and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Project Manager for Services to be rendered is hereby increased to an amount not to exceed two million one hundred nine thousand dollars and 00/100 (\$2,109,000.00), authorized as follows:
 - \$1,000,000.00 under the Agreement; and
 - \$ 575,000.00 under the First Amendment; and
 - \$ 534,000.00 under this Second Amendment.
- 3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.
- 4. The parties hereby agree to extend the Time of Performance under the Agreement to end no later than December 31, 2026.

- 5. BY ACCEPTANCE OF AGREEMENT, PROJECT MANAGER ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.
- **6.** Certain State Law Requirements for Contracts. The contents of this Section are required by Texas law and are included by County regardless of content For purposes of Sections 2252.152, 2271.002, and 2274.002, Texas Government Code, as amended, Contractor hereby verifies that Contractor and any parent company, wholly owned subsidiary, majority-owned subsidiary, and affiliate:
- A. Unless affirmatively declared by the United States government to be excluded from its federal sanctions regime relating to Sudan or Iran or any federal sanctions regime relating to a foreign terrorist organization, is not identified on a list prepared and maintained by the Texas Comptroller of Public Accounts under Section 806.051, 807.051, or 2252.153 of the Texas Government Code.
- B. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not boycott Israel and is authorized to agree in such contracts not to boycott Israel during the term of such contracts. "Boycott Israel" has the meaning provided in § 808.001 of the Texas Government Code.
- C. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not boycott energy companies and is authorized to agree in such contracts not to boycott energy companies during the term of such contracts. "Boycott energy company" has the meaning provided in § 809.001 of the Texas Government Code.
- D. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association and is authorized to agree in such contracts not to discriminate against a firearm entity or firearm trade association during the term of such contracts. "Discriminate against a firearm entity or firearm trade association" has the meaning provided in § 2274.001(3) of the Texas Government Code. "Firearm entity" and "firearm trade association" have the meanings provided in § 2274.001(6) and (7) of the Texas Government Code.
- 7. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.

Except as provided herein, the parties agree that all terms and conditions of the Agreement that have not been amended, shall remain unchanged.

IN WITNESS WHEROF, the County and the Project Manager have caused their respective duly authorized representatives to execute, seal and deliver this Amendment, all as of the date signed by the last party hereto.
