KNOW ALL MEN BY THESE PRESENTS:

THAT WE, TACKLE CONSTRUCTION, INC. whose (address, phone) is P.O. AND WHEREAS, the principal desires to provide Fort Bend County with a performance bond covering all such cable, conduit and/or pole line activity, commercial driveway and median openings or modifications;

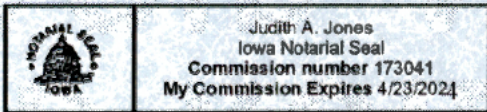
