## SECOND AMENDMENT TO AGREEMENT FOR CONSTRUCTION MATERIALS TESTING SERVICES

- In no case shall the amount paid by County for all Services under the Agreement and this Second Amendment exceed the Maximum Compensation without further written agreement executed by the parties.
- 3. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
