- County shall provide an additional Contract Deputy to District for an additional total estimated amount to perform additional law enforcement services, as described in the Cost Estimate Statement attached hereto as Exhibit "A-1" and incorporated herein for all purposes.
- Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
