AMENDMENT NO. 1 TO WORK AUTHORIZATION NO. 3 AGREEMENT FOR MARKETING SERVICES FOR FBC PUBLIC TRANSPORTATION WITH VESTA REA & ASSOCIATES, L.L.C. RFP 18-097

THIS FIRST AMENDMENT ("Amendment") is made and entered into by and between FORT BEND COUNTY, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and VESTA REA & ASSOCIATES, L.L.C., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas. County and Contractor are hereinafter collectively referred to as the "Parties" and each individually a "Party."

WHEREAS, by execution of this Amendment, the Parties desire to amend the Agreement to extend the time of performance with no increase in the total compensation and to otherwise ratify and confirm all the terms and conditions as set forth herein.

NOW THEREFORE, in consideration of the foregoing, the Parties do mutually agree that the Agreement between the Parties is hereby amended as follows:

- Dates of Performance. The times of performance shall extended to April 30, 2024.
- 2. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.

All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of Agreement. If there is a conflict between this First Amendment and Work Authorization No. 3, the provisions of this First Amendment shall prevail with regard to the conflict.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
