**THIRD AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and RPS Infrastructure, Inc., (hereinafter “Consultant”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on May 3, 2022, (hereinafter “Agreement”) pursuant to SOQ 14-025; and the Amendment to Agreement for Professional Engineering Services on February 28, 2023 (hereinafter “First Amendment”); and the Second Amendment to Agreement for Professional Engineering Services (hereinafter “Second Amendment”) on June 13, 2023, and both the Agreement, the First Amendment, and the Second Amendment are incorporated fully by reference as if set forth verbatim below; and

WHEREAS, the parties desire to amend the Agreement for additional professional engineering services to be provided and increase the total Maximum Compensation for such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Consultant an additional Twenty-Five Thousand, Eight Hundred Twenty dollars and 00/100 (\$25,820.00) for the additional professional engineering services as described in Consultant’s proposal dated September 1, 2023 attached hereto as Exhibit “A” and incorporated herein for all purposes.
2. The Maximum Compensation payable to Consultant for Services rendered is hereby increased to an amount not to exceed Five Hundred Thirty-Eight Thousand, Six Hundred Seventy dollars and 88/100 (\$538,670.88), authorized as follows:
 - \$398,665.00 under the Agreement; and
 - \$52,625.88 under the First Amendment;
 - \$61,560.00 under this Second Amendment; and
 - \$25,820.00 under this Third Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement, the First Amendment, this Second Amendment, and this

Third Amendment exceed the Maximum Compensation without further written agreement executed by the parties.

4. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement, the First Amendment, and Second Amendment shall remain unchanged.

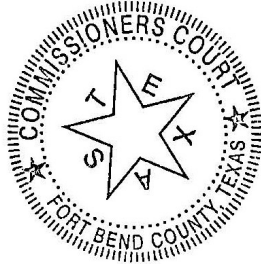

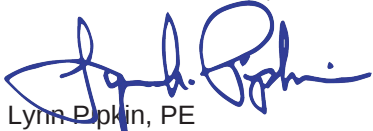

Ref: Request for an overhead electric line sag survey on Belknap Rd. in Fort Bend County, Texas.

Dear Mr. Odreman:

MBCO is pleased to submit this proposal for professional surveying services for the scope provided in an email on July 20, 2023, which will consist of locating overhead electric lines to show the height and sag in an area shown on shown in Exhibit "A" below.

CONTROL

- MBCO will tie into existing project control.

OVERHEAD ELECTRIC LINE SAG SURVEY

MBCO will perform a survey of the overhead electric lines at the CenterPoint easement crossing on Belknap Rd. and as shown on Exhibit "A".

- MBCO will locate the lowest transmission line crossing Belknap Rd. Elevations will be taken at the towers, center of road, and the center sag point.
- MBCO will survey the location of the CenterPoint Transmission towers, Natural ground at each tower, and a spot elevation at the sag location and centerline of Belknap Rd.
- Field notes will be taken noting the ambient temperature at the time of survey.
- MBCO will locate the lowest electric lines on the distribution poles and sag that cross Belknap Rd. in two locations just north of the CenterPoint easement.
- MBCO will locate the four power poles associated with the electric lines, a natural ground at each poles location, a spot elevation at the sag location and centerline of Belnap Rd.
- The survey information will be provided in a stand-alone CAD drawing that is referenced to original project control.
- The original survey will not be updated with this new information. Ther information will be referenced to original project control so it can be referenced to the original survey and design if necessary.



DELIVERABLES:

- Civil 3D CAD file of the collected data.
- Point File in the standard ASCII (P,N,E,Z,D) format.

SCHEDULE:

MBCO will complete the above-described scope of services within ten (10) business days from receiving the signed Notice to Proceed.

COMPENSATION:

Belknap Road survey \$ 2,195.00

The above-mentioned Surveying Services is a Lump Sum Fee, which will be billed at project completion or percent completion at the end of every month for the duration of the project, to be paid in full within 30 days of invoice date.
