The County Attorney is hereby authorized to settle all claims arising out of the demand attached hereto on the following terms:



2. A full release and dismissal of all claims and causes of action with prejudice.

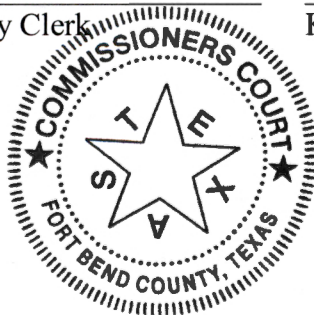
It is further ordered that FUND ACCOUNT **MOBILITY BONDS** BE DESIGNATED AS THE FUNDING SOURCE.

Re: Request for Reimbursement – Sanitary Sewer Relocation
Grand Mission Municipal Utility District No. 2

Dear Mr. Crawford:

I represent Grand Mission Municipal Utility District No. 2 ("District"). The engineer for the District, Quiddity, previously notified you of a request that Fort Bend County reimburse the District for the relocation of an existing sanitary sewer line at the intersection of Beechnut Street and Mason Road. Some recent pavement improvements necessitated moving the sanitary sewer line to avoid future pavement replacements to access the line. See Exhibit 1, the Quiddity correspondence.

The line has now been moved and the cost for doing so totals, to date, \$162,147.90. See Exhibit 2, the Projected Project Costs and associated backup documentation.

The District thus demands payment of \$162,147.90 from Fort Bend County for the relocation of this sanitary sewer line.
