Dear: Sienna/Johnson North LP

Fort Bend County is developing a Project to monitor flooding within the County. Fort Bend County is contacting landowners of property that identified as camera locations. The area needed for the camera and associated equipment would be obtained as an easement.

The enclosed Right-of-Entry Agreement/Temporary Construction Easement (ROW/TCE) provides a detailed explanation of the location and work. Project Limits: Various Locations

The undersigned property owner or authorized designee (Grantor) hereby grants unto Fort Bend County (County, and includes the County's consultants) a right-of-entry (ROE) and Temporary Construction Easement (TCE) upon the real property (Property) shown on the attached map (Attachment A) for the purpose of constructing improvements to monitor area flooding. (Agreement).

County has proposed to construct a Wireless Traffic Signal Communication System (Project). The Property has been identified as a location for a camera with associated equipment as shown in Attachment B. Equipment location shall be marked in the field for final approval by Grantor prior to commencing construction. After construction, the surface will be returned as closely as practicable to its original state. As built drawings will be provided to the Grantor along with final easement documents covering the area where permanent County improvements will remain.

The Grantor understands and agrees to the following terms and conditions:

- After granting the requested ROE/TCE, the Grantor, or authorized agent with signatory responsibilities reserves all rights, titles and interest in and to the Property.
- The ROE/TCE shall not prejudice the Grantor's rights to any relocation benefits for which the Grantor or Grantors would otherwise be eligible.
- The Grantor, Grantors or authorized representative with signatory authority, grants County access to perform the construction activity at its own risk and expense. Grantor shall not be liable for any destruction of, or damage to, the Project arising out of or in connection with the construction, installation, replacement, maintenance, operation, or removal of the Project. Temporary flagging or temporary markers may be used to located specific features or survey points at the Property.
- Upon completion of construction, the County will, at its sole cost and expense, restore the Property to its original condition.
- County and Grantor agree that the primary point of access to the Property shall be from Bees Passage; however, County is authorized to cross other portions of the Property in order to gain access for purposes of the Project, if necessary. County is required to provide notice to Grantor twenty-four (24) hours prior to gaining access.
- The Agreement shall be effective the date it is executed and shall remain in effect until final easement documents are approved by both Parties or one (1) year from the effective date of this Agreement, whichever is earlier.
- The Grantor may be present during the construction. Please indicate the preferred method for notification at the bottom of the form.
- County will provide at least twenty-four (24) hours notice prior to construction activities to the individuals indicated at the bottom of the form.
- The ROE/TCE, unless revoked or terminated, shall extend to and bind the signatory parties, their
 heirs, executors, administrators, legal representatives, successors, and assigns, including the
 contractors, consultants, agents and all others County has deemed necessary to share in this
 ROE/TCE.
- The County warrants that prior to it or any contractor or subcontractor(s) performing any
 construction on the Property, said contractor and or subcontractor(s) shall furnish to Grantor
 verification of insurance coverages for the Project. The County will add Grantor as an additional





- insured for all insurance required under the construction contract for the Project, to the same extent and in the same manner as the County.
- If the Grantor is not the original individual, by signature, the undersigned authorized representative of the Grantor with signatory authority warrants and represents that he or she is duly authorized and empowered to enter into and to execute the ROE/TCE on behalf of the Grantor.
- If the Property is owned by multiple Grantors, all legal Grantors must sign this ROE/TCE Form for it to be effective.


