**SECOND AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS SECOND AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and Woolpert, Inc. (hereinafter “Consultant”), a company authorized to conduct business in the State of Texas.

WHEREAS, CivilTech Engineering, Inc. is now known as Woolpert, Inc.; and

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on June 22, 2021 pursuant to SOQ 14-025, and as amended on or about December 5, 2023, collectively referred to as the “Agreement” and incorporated fully by reference for all purposes; and

WHEREAS, the parties desire to amend the Agreement to allow Consultant to provide additional Services under the Agreement, and to increase the Maximum Compensation amount.

NOW, THEREFORE, the parties do mutually agree as follows:

1. All references to CivilTech Engineering, Inc., under the Agreement, will hereinafter be referred to as Woolpert, Inc.
2. County shall pay Consultant an additional amount not to exceed Fourteen Thousand, Eight Hundred Eighty-Three dollars and 90/100 (\$14,883.90) to perform the additional Services, as described in Consultant’s proposal dated December 7, 2023, attached hereto as Exhibit “A-2” and incorporated herein for all purposes.
3. The Maximum Compensation payable to Consultant for all Services rendered is hereby increased to an amount not to exceed Five Hundred Forty-Five Thousand, Seven Hundred Eighty-Five dollars 50/100 (\$545,785.50), authorized as follows:
 - \$ 518,398.00 under the Agreement;
 - \$ 12,503.60 under the First Amendment; and
 - \$ 14,883.90 under this Second Amendment.

4. In no case shall the amount paid by County for all Services under the Agreement, the First Amendment, and this Second Amendment exceed the Maximum Compensation without an agreement executed by the parties.
5. BY ACCEPTANCE OF AGREEMENT, CONSULTANT ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.
6. Certain State Law Requirements for Contracts. The contents of this Section are required by Texas law and are included by County regardless of content For purposes of Sections 2252.152, 2271.002, and 2274.002, Texas Government Code, as amended, Contractor hereby verifies that Contractor and any parent company, wholly owned subsidiary, majority-owned subsidiary, and affiliate:
 - A. Unless affirmatively declared by the United States government to be excluded from its federal sanctions regime relating to Sudan or Iran or any federal sanctions regime relating to a foreign terrorist organization, is not identified on a list prepared and maintained by the Texas Comptroller of Public Accounts under Section 806.051, 807.051, or 2252.153 of the Texas Government Code.
 - B. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not boycott Israel and is authorized to agree in such contracts not to boycott Israel during the term of such contracts. "Boycott Israel" has the meaning provided in § 808.001 of the Texas Government Code.
 - C. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not boycott energy companies and is authorized to agree in such contracts not to boycott energy companies during the term of such contracts. "Boycott energy company" has the meaning provided in §809.001 of the Texas Government Code.
 - D. If employing ten (10) or more full-time employees and this Agreement has a value of \$100,000.00 or more, Contractor does not have a practice, policy, guidance, or directive that discriminates against a firearm entity or firearm trade association and is authorized to agree in such contracts not to discriminate against a firearm entity or firearm trade association during the term of such contracts. "Discriminate against a firearm entity or

firearm trade association” has the meaning provided in §2274.001(3) of the Texas Government Code. “Firearm entity” and “firearm trade association” have the meanings provided in §2274.001(6) and (7) of the Texas Government Code.

7. Recitals. The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
8. Except as provided herein, the parties agree that all terms and conditions of the Agreement shall remain unchanged.



DRAINAGE EASEMENT SURVEYING SERVICES

Koeblen Road Segment 3 – from FM 2218 to the City of Rosenberg City Limits

I. LAND SURVEYING SERVICES

KCI will gain necessary rights of entry (ROE) from the private landowners.

A. Re-Establish Control and TBMs

Fort Bend County horizontal control points and vertical benchmarks by others will be recovered and used as reference. Temporary Benchmarks and baseline control points will be established at an approximate 1,000-foot interval from beginning to end of the project for construction purposes. Every attempt will be made to select locations that will not be lost during construction.

All bearings and coordinates will be based on the Texas Coordinate System of 1983 (NAD 83), South Central Zone 4204. Benchmark elevations will be referenced to the same datum as the effective Fort Bend County Flood Insurance Rate Map by observations on a minimum of three existing Reference Monuments.

B. Survey Control Maps

The Surveyor will prepare a sealed Survey Control Map Sheet and a Control Detail Sheet for the project which includes the proposed right-of-way line, the survey control baseline, Temporary Benchmarks and the project baseline. Client to provide a digital copy of the sheet file border and format for use by KCI Technologies.

The survey control deliverables will be provided at a suitable scale for use in 11" x 17" and 22" x 34" formats.
