Justin Jurek, Fire Marshal gave an overview of a fire that occurred at Frank's Nursery on FM 359. There was a major fire that began Friday, March 29 and continued into a multiday incident. Chief Jurek thanked all the departments who helped with keeping the work going around the clock. In order to assure the safety of the citizens there was air monitoring to the north of the scene with Hazmat and periodic water testing was done around the facility.

Commissioner Morales thanked Chief Jurek and his team and all of the County Agencies and City Agencies that came out to help. Many of the messages he received from the neighboring community was at first a sense of panic. On Easter there was a sign of relief knowing Fort Bend County was there taking care of this fire.

Commissioner McCoy thanked Road and Bridge as well for their tireless efforts.
