**AMENDMENT TO BUS WRAP SERVICES AGREEMENT  
RFP-20-067**

**THIS FIRST AMENDMENT** ("Amendment") is made and entered into by and between **FORT BEND COUNTY**, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and **SIGN-UPS AND BANNERS**, (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas. County and Contractor are hereinafter collectively referred to as the "Parties" and each individually a "Party."

WHEREAS, the Parties executed and accepted that certain *Agreement for Bus Wrap Services* executed on January 5, 2021 (hereinafter "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, by execution of this Amendment, the Parties desire to amend the Agreement to revise Exhibit C of the Agreement and to otherwise ratify and confirm all the terms and conditions as set forth herein.

NOW THEREFORE, in consideration of the foregoing, the Parties do mutually agree that the Agreement between the Parties is hereby amended as follows:

1. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
2. **Exhibit C.** Exhibit C shall now be replaced by Contractors updated Price Worksheet attached to this Amendment as Exhibit A. The new rates reflected therein shall represent Contractors new rate of compensation under the Agreement moving forward.

All terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of Agreement. If there is a conflict between this First Amendment and the Agreement, the provisions of this First Amendment shall prevail with regard to the conflict.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

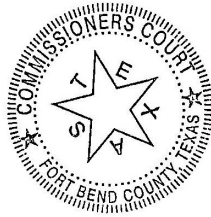
