3. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
4. **Modifications and Conflict.** Except as modified herein, the Agreement shall remain in full force and effect and has not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, this Amendment shall prevail with regard to the conflict.

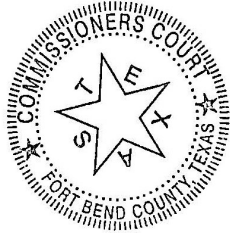

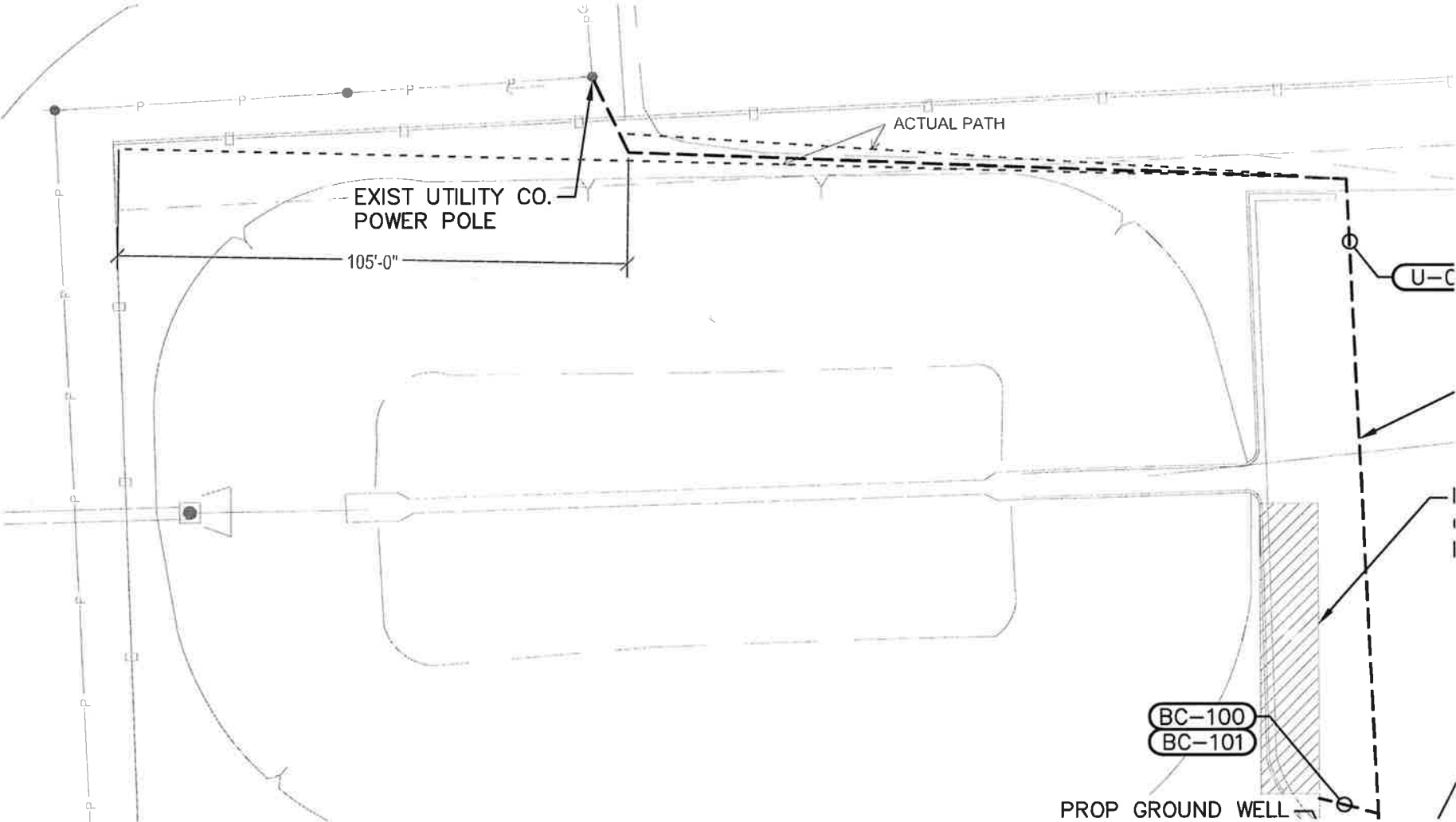

We appreciate the opportunity to present this proposal for additional electrical engineering services in connection with the Fort Bend County Cricket Field.

Project Understanding

The cricket field lighting feeder circuits were designed around a single-phase 480V feeder to each of the four poles. The lighting package supplier and electrician requested a re-design of the proposed feeder circuits to supply a three-phase 480V feeder instead of the single-phase feeder. The new three-phase feeders will require new voltage drop calculation which will affect the conduit and wiring sizing.

Scope of Services

A. Additional Electrical Design Phase Services

1. The revised electrical construction drawings shall include the following:
 - a. Revised electrical one-line diagram to reflect three-phase lighting feeders.
 - b. Revised conduit schedule specifying conductor and conduit sizes.
