FIRST AMENDMENT TO AGREEMENT FOR SECURITY SERVICES

(Utilizing Choice Partners Purchasing Cooperative Contract No. 22/047 MR)

THIS FIRST AMENDMENT ("Amendment") is made and entered into by and between FORT BEND COUNTY, TEXAS ("County"), a political subdivision of the state of Texas, and BLUE KNIGHT SECURITY, LLC ("Contractor"), a limited liability company duly authorized to conduct business in the state of Texas. County and Contractor may be referred to individually as a "Party" or collectively as the "Parties."

WHEREAS, County and Contractor have executed and executed that certain Agreement for Security Services on March 26, 2024 (hereinafter "Agreement"), which is incorporated by reference as if set forth herein verbatim;

WHEREAS, by execution of this Amendment, the parties desire to amend the Agreement to increase the Total Maximum Compensation for additional services, and otherwise ratify and confirm all the terms and conditions as set forth herein.

NOW, THEREFORE, in consideration of the foregoing, the parties do mutually agree that the Agreement between the parties is hereby amended as follows:

1. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of this Agreement.
2. **Scope of Services.** Subject to the terms of the Agreement, as amended, County shall pay Contractor an additional Six Thousand and no/100 dollars (\$6,000.00) to continue to provide Security Services.
3. **Limit of Appropriation.** Contractor understands and agrees that the Maximum Compensation payable to Contractor for Services rendered under this Agreement is hereby increased to an amount not to exceed Fifty-six Thousand and no/100 dollars (\$56,000.00), authorized as follows:

\$50,000.00	under the Agreement
\$6,000.00	under this Amendment
TOTAL	\$56,000.00

In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.

Contractor clearly understands and agrees, such understanding and agreement being of the absolute essence of this Agreement, that the total maximum sum of Fifty-six Thousand and no/100 dollars (\$56,000.00), specifically allotted to fully discharge any and all liabilities County may incur under this Agreement.

Contractor further understand and agree, said understanding and agreement also being of the absolute essence of this Agreement, that the total maximum compensation that Contractor may be entitled to and the total maximum sum that County may become liable to pay Contractor shall not under any conditions, circumstances, or interpretations thereof exceed Fifty-six Thousand and no/100 dollars (\$56,000.00).

4. **Modification and Conflict.** Except as modified herein, the terms of the Agreement, as amended, shall remain in full force and effect and have not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, as amended, this Amendment shall prevail with regard to the conflict.

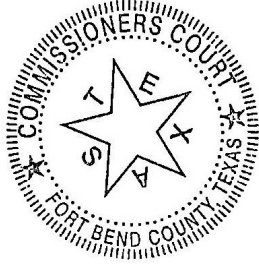
