SIXTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS SIXTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES (the "Sixth Amendment"), is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Bowman Consulting Group, Ltd. (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on May 22, 2018 (hereinafter "Agreement") pursuant to SOQ 14-025, as amended by documents executed on February 2, 2019 (hereinafter "Amendment"), July 9, 2019 (hereinafter "Second Amendment"), June 2, 2020 (hereinafter "Third Amendment"), February 22, 2022 (hereinafter "Fourth Amendment"), and April 25, 2023 (hereinafter "Fifth Amendment"); and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided and increase the total Maximum Compensation under the Agreement for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. County shall pay Contractor an additional amount not to exceed forty-nine thousand six hundred dollars and 00/100 (\$49,600.00) to perform the additional Services, as described in Contractor's proposal dated July 12, 2024, attached hereto as Exhibit "A" and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed one million three hundred fifty thousand five hundred eighty dollars and 00/100 (\$1,350,580.00), authorized as follows:
 - \$1,045,280.00 under the Agreement;
 - \$ 132,000.00 under the Amendment:
 - \$ 15,800.00 under the Second Amendment;
 - \$ 45,300.00 under the Third Amendment;
 - \$ 62,600.00 under the Fourth Amendment;
 - \$ 0.00 under the Fifth Amendment; and
 - \$ 49,600.00 under this Sixth Amendment.

- 3. In no case shall the amount paid by County for all Services under the Agreement and this Sixth Amendment exceed the Maximum Compensation without an agreement executed by the parties.
- 4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
