EXTENSION OF AGREEMENT FOR CONTINGENCY ALL HAZARDS CONSULTING SERVICES PURSUANT TO RFP 19-041 – SECONDARY

THIS EXTENSION is made and entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and Hagerty Consulting, Inc. ("Consultant"), a company authorized to conduct business in the State of Texas.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth herein, and in the Agreement, the parties hereby renew the term of the Agreement as follows:

EXTENSION

1. Term

This Extension is effective beginning December 1, 2024 and will expire on January 31, 2025.

2. Effect of Extension

Except as expressed herein, the terms of the Agreement remain in full force and effect. If there is a conflict between this Extension and the Agreement, the provisions of this Extension shall prevail. This Extension shall be effective upon execution by the County.
