- Traffic Radar Trailer Batteries; to replace the old batteries,

Justification

1. Digital Forensics Laptop: Evidence in criminal investigations has rapidly transitioned from physical to digital form. Every person has a cell phone, and most vehicles today have on-board computers. The technology required to extract the evidence contained within demands high-performance computers. This evidence, in addition to massive downloads from social media companies, must then be analyzed

and cataloged. Finally, the digital evidence must be presented to a jury. Smaller computers with less computing power cannot store nor present this evidence, materially damaging the prosecution.

2. External Hard Drive: With the increase in digital evidence, sizeable storage and portability is a necessity. Once a rarity to download a cell phone, it has become a standard tool in criminal investigations. The cell phone dumps are large digital files that cannot claim all our space on the county's network, and flash drives are simply too small and fragile. The county's standard issue laptops do not have the internal storage capacity either. These drives will outfit each investigator with enough space and with an upgraded transmission speed to allow evidence retention and evaluation when not using a digital forensic laptop.
3. Video Editing Desktop: Digital evidence often requires the advanced ability to edit, redact, or amplify audio/video files. This can be ordered by the court before evidence is admissible in trial. A high-end desktop with included graphics card is built beyond the standard machines our investigators use. This Microsoft Windows computer will compliment our Apple computers that run cinematic-grade video-editing software.
4. Portable Printer + Ink Bundle: Our investigators are also mobile, and previous JAG requests have supported MDT laptops to keep them connected on the road. We are attending more crime scenes and initiating investigations – from vehicular crimes to officer-involved shootings, that may require print capability on location.

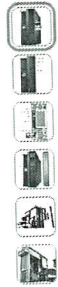

The Fort Bend County Sheriff's Office seeks to fund the purchase of a speed trailer as part of the traffic enforcement program under the Edward Byrne Justice Memorial Grant. The total funding amount for this project is \$11,999.00.

A second project involves the effort to fund transmitter bracelets for autistic, persons with intellectual learning disorders, and dementia/ Alzheimer's disease who are prone to wandering. As part of Project Lifesaver, this is a request to purchase transmitters and bracelets at a cost of \$7,200.00.

The total amount requested is \$19,199.00. The Project Lifesaver transmitters and bracelets are scalable.

Problem Statement:

Fort Bend County is reportedly one of the top Texas counties with large numbers of major crashes and fatalities. The Texas Department of Transportation ranks Fort Bend County as the 8th highest County for crashes and fatalities. Between January 1, 2021, and September 1, 2024, 35 fatality crashes were recorded involving DUI/DWI, 22 fatality crashes were recorded in which a seat belt was not used, 26 fatalities involved excessive speed, and 3 fatality crashes resulted from distracted driving.

With respect to commercial motor vehicles, during the same time period, 14 fatalities involved DUI/DWI drivers, 21 fatalities were related to non use of seat belts, 22 involved excessive speed, 35 occurred at intersections, and 2 fatalities resulted from distracted driving.

Speed is also a contributing factor to the many pedestrian and pedestrian cyclist accidents reported in and around school zones. This year, 67 auto-pedestrian accidents were reported, 241 failure to stop and give information, and 4,500 non-injury crashes. The total number of crashes, January 1 through October 1 is 5,662.

A substantial part of the Fort Bend County population manages illnesses related to autism, Alzheimer's/dementia, and intellectual learning disorders. Recently, several children with autism left their homes and drowned in nearby ponds. Persons with Alzheimer's and dementia as well as intellectual learning disorders are also prone to wandering.

The transmitters and bracelets provided by Project Lifesaver enable Sheriff's deputies to locate persons who have wandered by immediately deploying readers to locate signals from their bracelets.

Purpose:

The purpose of the traffic enforcement project is to increase driver awareness of their speed, and to improve public safety.

A direct benefit of the speed trailer is its immediate messaging to approaching drivers with indication of their speed. Given that speeding drivers are also striking pedestrians, such as children on their bicycles or as pedestrians walking to school, the trailer can contribute to reduced speed and improved safety.

The purpose of Project Lifesaver is to locate person who have left their homes before any harm can come to them or before they are subject to exploitation by predators.

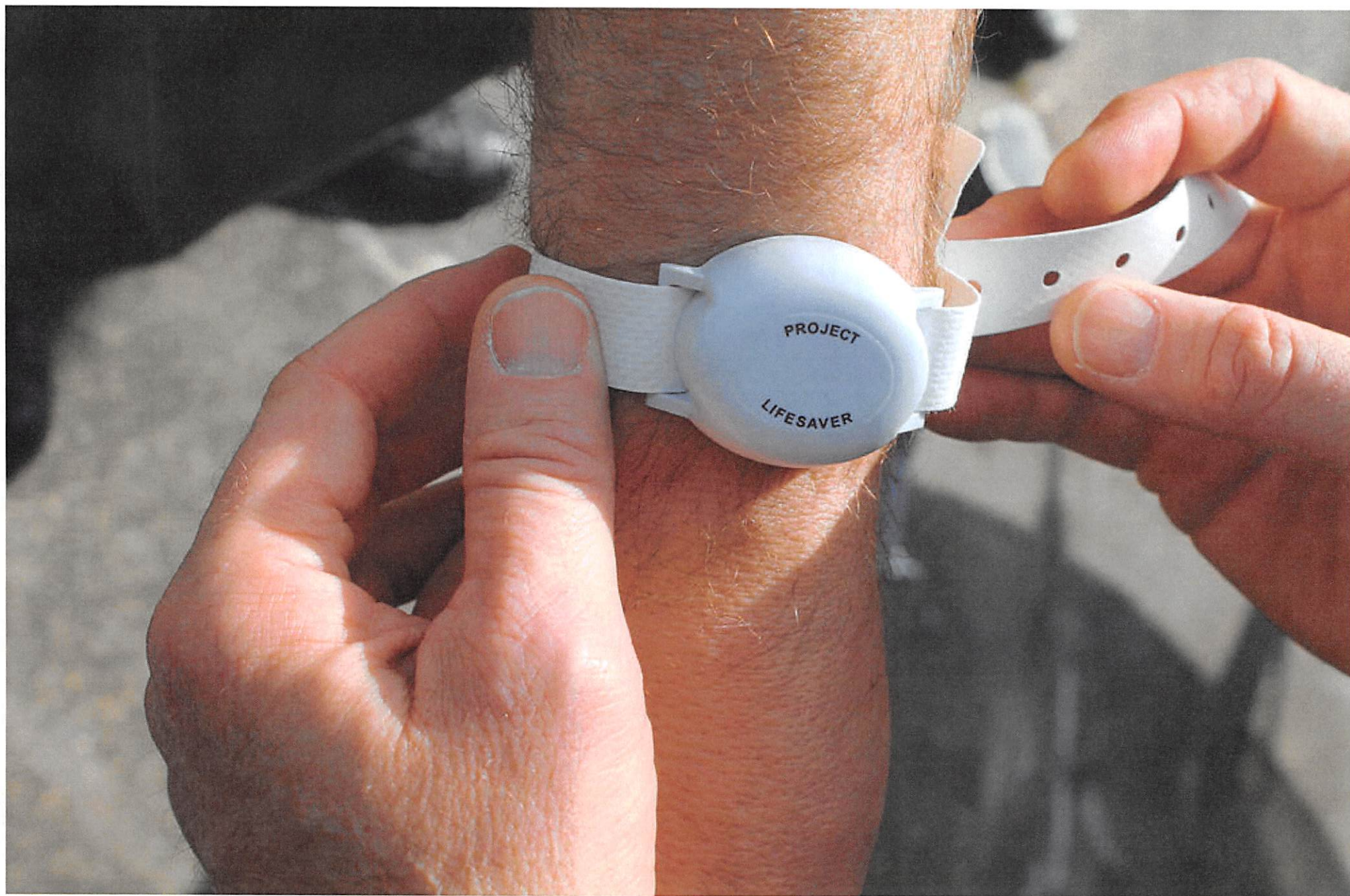

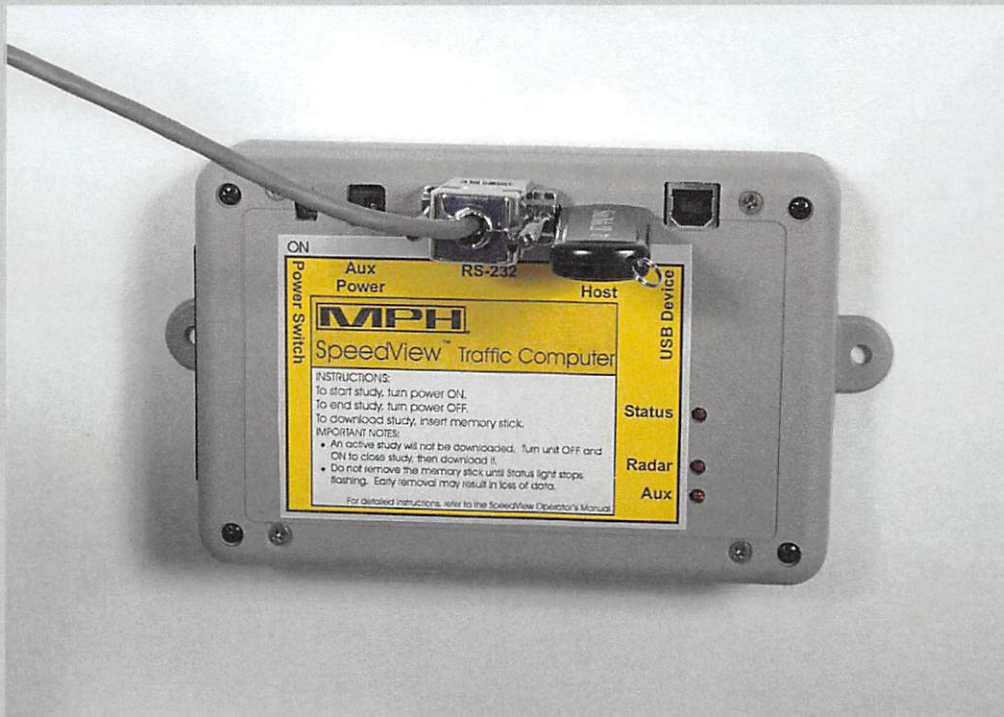
