THIRD AMENDMENT TO INSIGHT PUBLIC SECTOR, INC.'S AGREEMENT (DIR CONTRACT NO. DIR-CPO-5239)

THIS THIRD AMENDMENT ("Third Amendment") is entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and Insight Public Sector, Inc., ("Insight"), a company authorized to conduct business in the State of Texas (collectively referred to as the "parties").

WITNESSETH:

WHEREAS, the parties previously entered into the Addendum to Insight Public Sector, Inc.'s Agreement, on or about November 22, 2022, for the purchase of specified Adobe software subscriptions and licenses, and as amended on or November 21, 2023, and again on May 14, 2024, collectively referred to as the "Agreement" and incorporated fully by references for all purposes; and

NOW, THEREFORE, County and Insight desire to amend said Agreement as set forth below:

I. Amendments

- Scope of Services. Insight shall continue to provide product and/or services to County as described Insight's Quotation, dated October 4, 2024, attached as Exhibit "A-3" and incorporated fully by reference, and in accordance with the requirements and specifications of DIR Contract No. DIR-CPO-5239.
- 2. Term. This Agreement shall renew and this Third Amendment is effective as of December 1, 2024, and shall expire no later than November 30, 2025, unless terminated sooner pursuant to this Agreement. Neither the Agreement nor this Third Amendment shall automatically renew, but may renew upon written agreement of the parties.
- Limit of Appropriation. Insight's fees shall be calculated at the rates set forth in the attached Exhibit A-3. The Maximum Compensation for the performance of services within the Scope of Services as described in Exhibit A-3 is \$155,814.90. In no case shall the amount paid by County under this Third Amendment exceed this Maximum Compensation without an approved change order. Insight clearly understands and agrees, such understanding and agreement being of the absolute essence of this Third Amendment, that County shall have available the total maximum sum of \$155,814.90, specifically allocated to fully discharge any and all liabilities County may incur arising from this Third Amendment. Insight does further understand and agree, said understanding and agreement also being of the absolute essence of this Third Amendment, that the total maximum compensation that Insight may become entitled

to and the total maximum sum that County may become liable to pay to Insight shall not under any conditions, circumstances, or interpretations thereof exceed \$155,814.90.

- 4. Conflict. If there is a conflict among documents, the most recently executed document will prevail with regard to the conflict. In the event of a conflict between the Agreement and the terms and conditions of DIR Contract No. DIR-CPO-5239, then the terms and conditions of DIR Contract No. DIR-CPO-5239 controls to the extent of the conflict.
- 5. **Modifications**. Except as modified herein, the Agreement remains in full force and effect and has not been modified or amended.
- 6. **Understanding, Fair Construction.** By execution of this Third Amendment, the parties acknowledge that they have read and understood each provision, term and obligation contained in this Third Amendment. This Third Amendment, although drawn by one party, shall be construed fairly and reasonably and not more strictly against the drafting party than the nondrafting party.
- 7. **Severability.** If any provision of this Agreement is determined to be invalid, illegal, or unenforceable, the remaining provisions remain in full force, if the essential terms and conditions of this Agreement for each party remain valid, binding, and enforceable.
