**THIRD AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL ENGINEERING SERVICES**

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and R.G. Miller Engineers, Inc. (hereinafter “Contractor”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on May 8, 2018 pursuant to SOQ 14-025, as amended by document executed on April 6, 2021, and amended again by document executed on April 5, 2022, (collectively, hereinafter “Agreement”); and

WHEREAS, the parties desire to further amend the Agreement to extend the time of performance under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

1. The parties agree the terms and conditions of the Agreement have remained in effect to date, and the time of performance under the Agreement is hereby extended to end no later than December 31, 2025, as described in Contractor’s proposal dated October 22, 2024 attached hereto as Exhibit “A” and incorporated herein for all purposes.
2. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement and any subsequently executed amendment shall remain unchanged.

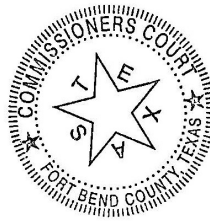
