WHEREAS, the parties desire to amend the Agreement to extend time for performance under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.
- 2. The Time of Performance under the Agreement is hereby extended to December 31, 2026.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
