**FIRST AMENDMENT TO AGREEMENT FOR
 PROFESSIONAL STRUCTURAL ENGINEERING DESIGN SERVICES
 BLUERIDGE PARK EXPANSION PROJECT**

THIS FIRST AMENDMENT (hereinafter "Amendment") is made and entered into by and between **FORT BEND COUNTY**, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and **JAYMARK ENGINEERING CORPORATION**, (hereinafter "Jaymark" or "Consultant"), a company authorized to conduct business in the State of Texas. County and Jaymark may be referred to individually as a "party" or collectively as the "parties."

WHEREAS, on or about November 21, 2023, the Parties entered into Agreement for Professional Structural Engineering Design Services Blueridge Park Expansion Project (hereinafter "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, the parties desire to amend the Agreement to increase the Total Maximum Compensation under the Agreement for the completion of such additional services to be provided thereunder;

WHEREAS, County desires Consultant provide services as will be more specifically described in this Agreement (hereinafter "Services");

WHEREAS, Consultant represents that it is qualified and desires to perform such services;

NOW THEREFORE, in consideration of the mutual covenants and conditions set forth below, the parties agree:

1. County shall pay Contractor an additional Six Thousand Five Hundred and no/100 dollars (\$6,500.00) to provide additional Services as described the Scope of Services dated October 29, 2024, attached as Exhibit "A" and incorporated by reference for all purposes, under the terms and conditions of the Agreement.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed Seventy-One Thousand Three Hundred and no/100 dollars (\$71,300.00), authorized as follows:

3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written agreement executed by both parties.

4. The parties agree the terms and conditions of the Agreement have remained in effect to date.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

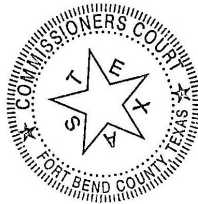

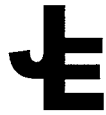
