## FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES

(Huitt-Zollars, Inc. – Drainage Masterplan for West of City of Rosenberg)

THIS FIRST AMENDMENT ("First Amendment") is entered into by and between Fort Bend County Drainage District ("District"), a special district organized under the laws of the state of Texas, and Huitt-Zollars, Inc. ("CONSULTANT"), a Texas corporation. District and CONSULTANT are hereinafter collectively referred to as the "Parties" and each individually a "Party."

WHEREAS, the Parties previously entered into that certain agreement on January 15, 2025 (the "Agreement") for Professional Engineering Services for a Drainage Masterplan for 22.6 square-mile of area west of the City of Rosenberg; and

WHEREAS, by execution of this First Amendment, the Parties desire to amend the Agreement to extend the Time for Performance under the Agreement, and to otherwise ratify and confirm all the terms and conditions as set forth therein.

NOW, THEREFORE, in consideration of the foregoing, the Parties do mutually agree that the Agreement between the Parties is hereby amended as follows:

- 1. **Time for Performance**. The parties mutually agree the terms and conditions have remained in effect to date and the Time of Performance under the Agreement shall be extended to end no later than October 25, 2025. CONSULTANT shall complete the Services as within this time or within such additional time as may be extended by County.
- 2. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
- 3. **Human Trafficking.** BY ACCEPTANCE OF THIS FIRST AGREEMENT, CONSULTANT ACKNOWLEDGES THAT FORT BEND COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO DISTRICT FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.
- 4. **Modifications and Conflict.** Except as modified herein, the Agreement shall remain in full force and effect and has not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, this First Amendment shall prevail with regard to the conflict.
