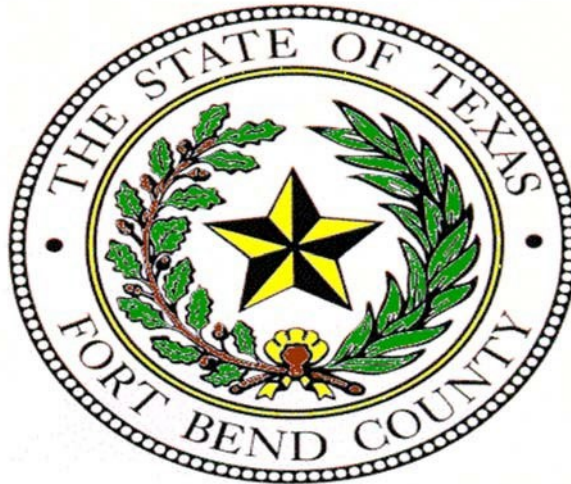

PROPOSED BUDGET OF FORT BEND COUNTY, TEXAS FOR FISCAL YEAR 2026

The **Fort Bend County** budget will raise more revenue from property taxes than last year's budget by an amount of \$2,182,997 or 0.43%, and of that amount \$12,913,214 is tax revenue to be raised from new property added to the tax roll this year.

The **Fort Bend County Drainage District** budget will raise more revenue from property taxes than last year's budget by an amount of \$96,791 or 0.77%, and of that amount \$313,428 is tax revenue to be raised from new property added to the tax roll this year.
