AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Geoscience Engineering & Testing, Inc., (hereinafter "GETI"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on June 27, 2023, for Materials Testing and Inspection Services for the proposed roundabout located at Voss Road at Old Richmond Road in Sugar Land, Texas under Mobility Bond Project Nos. 17404 and 17413 pursuant to SOQ 14-025, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to allow GETI to provide additional Services under the Agreement and to increase the maximum compensation amount.

NOW, THEREFORE, the parties do mutually agree as follows:

- County shall pay GETI an additional amount not to exceed Fifty-Five Thousand Four Hundred Ninety and 00/100 Dollars (\$55,490.00) to perform the additional Services, as described in GETI's Proposal No. 23025 dated March 6, 2023, attached hereto as Exhibit "A-1" and incorporated herein for all purposes.
- The Maximum Compensation payable to Consultant for all Services rendered is hereby increased to an amount not to exceed Ninety Thousand Five Hundred Eighty and 50/100 Dollars (\$90,580.50), authorized as follows:

\$35,090.50 under the Agreement; and \$55,490.00 under this Amendment.

 In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without a written agreement executed by the parties.

4. BY ACCEPTANCE OF AGREEMENT, GETI ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

IN WITNESS WHEREOF, the parties hereto have signed or have caused their respective names to be signed to multiple counterparts to be effective on the date signed by the final party.
