THIRD AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County”), a body corporate and politic under the laws of the State of Texas, and CivilCorp, LLC, (hereinafter “Contractor”), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on June 12, 2018, pursuant to SOQ 14-025, as amended by document executed on December 3, 2019, and as amended again by document executed on December 6, 2022 (collectively, hereinafter “Agreement”); and

WHEREAS, the parties desire to further amend the Agreement to extend the Time of Performance under the Agreement, as described in Contractor’s proposal dated October 22, 2024 attached hereto as Exhibit “A” and incorporated herein for all purposes.

NOW, THEREFORE, the parties do mutually agree the terms and conditions have remained in effect to date and the Time of Performance under the Agreement shall be extended to end no later than December 31, 2026.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

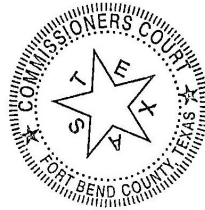
