THIRD AMENDMENT TO AGREEMENT FOR PLAN, SPECIFICATION, AND ESTIMATE DESIGN SERVICES

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Gannett Fleming, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Plan, Specification, and Estimate Services on December 18, 2018 pursuant to SOQ 14-025, which was subsequently amended on or about July 6, 2021 and September 26, 2023, (hereinafter collectively referred to as the "Agreement"); and

WHEREAS, the parties desire to amend the Agreement to allow Contractor to provide additional Services under the Agreement and for an increase in the maximum compensation under the Agreement.

NOW, THEREFORE, the parties do mutually agree as follows:

- County shall pay Contractor an additional amount not to exceed one hundred ninety-five thousand seven hundred twenty-nine dollars and 78/100 (\$195,729.78) to perform the additional Services, as described in Contractor's Supplemental Scope and Fee Proposal attached hereto as Exhibit "A-3" and incorporated herein for all purposes.
- 2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed five million seven hundred ninety-three thousand three hundred eighty-seven dollars and 00/100 (\$5,793,387.00), authorized as follows:
 - \$ 4,868,888.00 under the Agreement;
 - \$ 491,503.00 under the First Amendment;
 - \$ 237,266.22 under the Second Amendment; and
 - \$ 195,729.78 under this Third Amendment.
- 3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.

4. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

IN WITNESS WHEREOF, the parties hereto have signed or have caused their respective names to be signed to multiple counterparts to be effective on the date signed by the final party.

1. UPRR Exhibit A Packages

Based on direction from TxDOT District and RR Division in Austin, new UPRR documents were prepared, and previously submitted documents were revised to accommodate new standards and requirements. Additional Scope items associated with this change include the following:

- Updated RR Scope of Work Sheets were required due to an updated form issued by TxDOT.
- A new proposed steel drainage pipe crossing UPRR at Evergreen required new plans and a separate Exhibit A Package.
- UPRR required the following reports for the proposed 6'x3' RCB crossing the RR tracks at Broadway, a drainage crossing that was added during design to accommodate drainage from Fort Bend County's Lake Olympia Parkway project:
 - 1) Design Summary Report with Calculations, Installation Method, Track and Ground Monitoring Plan, and Coupler System for box culvert joints.
 - 2) Geotechnical Report and Quantitative Surface Settlement Analysis to verify installation feasibility.

2. City of Pearland Coordination and Design Changes

Gannett Fleming (GF) coordinated with the City of Pearland, TxDOT, and Fort Bend County to finalize an agreement between the City and TxDOT. Additional Scope items associated with this task include:

- Coordination with TxDOT and City to facilitate transfer of Parcel 115 ROW to TxDOT.
- Preparation of Exhibits to define TxDOT's maintenance limits and impacts to the City's facilities from construction of the Broadway Overpass (street lighting, irrigation, utilities, etc.).

- Revisions to proposed North and South Access Road (Broadway Street) Traffic Signals to remove City requirements, including Gridsmart Vehicle Detection System and black powder coating.
- Review of new proposed traffic signal at Shadow Grove Lane, including changes to Broadway Street Plan & Profile sheets and Signing and Pavement Marking Plans.
- Preparation of Utility Relocation Plan & Profile sheets and Standard Utility
 Agreement to provide water and sanitary sewer access to the remaining property
 south of the South Access Road. TxDOT will add the relocation work to their
 contract via a change order.

3. Republic Services / Blue Ridge Landfill

Gannett Fleming (GF) coordinated with the Republic Services, TxDOT, and Fort Bend County to finalize acquisition of the property for the FM 521 and Lake Olympia Parkway projects. Additional Scope items associated with this task include:

- Monthly meetings to discuss the project and resolve questions and concerns from Republic Services.
- Revision of the Broadway Street Plan & Profile sheets to accommodate the following requests from Republic Services:
 - 1) Add a right-turn lane to their property.
 - 2) Re-align the proposed driveway tie-in.
 - 3) Reconfigure the proposed median opening.
- Review of request from Republic Services to add new traffic signal at driveway to landfill, including signal warrant analysis and technical memo documenting the results.

4. Side Street Modifications

Per direction from Fort Bend County, GF will review the updated design information and revise the FM 521 plans at the following side street tie-ins:

- West and East Sycamore Street
- Ladona Street / Renfro-Burford Road
- Post Road
