WHEREAS, the Commissioners Court of Fort Bend County, Texas ("Commissioners Court"), has heretofore appointed Robert McBride to the Board of Directors of First Colony Levee Improvement District (the "District") to complete the four-year term of office through February 12, 2028, that was left vacant after Richard Sherrill passed away; and

WHEREAS, the Commissioners Court desires to appoint Robert McBride to serve as Director for the District to complete the lawful four-year term of office that commenced effective February 12, 2024, and expires on February 12, 2028, or until his successors shall be appointed and qualified; and

WHEREAS, Robert McBride is over twenty-one years of age, a resident citizen of the State of Texas, otherwise qualified by law to serve as a Director of the District, and not disqualified from serving as a Director of the District by reason of any law; and

WHEREAS, Title 4, Chapter 57 of the Texas Water Code, as amended, confers jurisdiction on the County Judge and Commissioners Court of Fort Bend County, Texas to appoint the Directors of the District; Now Therefore,



Section 3: A copy of the Order shall be recorded in the minutes of this Court.

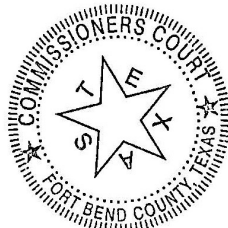

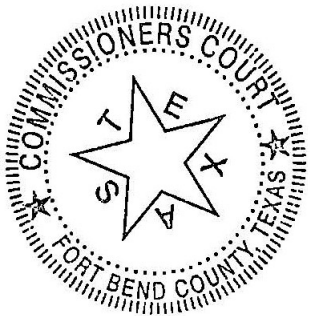
