## FIRST AMENDMENT TO AGREEMENT FOR GENERAL CONTRACTOR SERVICES FOR THE CONSTRUCTION OF THE WESTPARK PARK & RIDE

(SpawGlass Civil Construction, Inc. - RFP 23-057)

This First Amendment ("First Amendment") is made and entered into by and between Fort Bend County, Texas ("County"), a political subdivision of the state of Texas, and SpawGlass Civil Construction, Inc. ("Contractor"), a Texas corporation. County and Contractor may be referred to individually as a "Party" or collectively as the "Parties."

WHEREAS, the parties executed and accepted that certain Agreement for general contracting services for the construction of the Westpark Park & Ride located in Richmond, Fort Bend County, Texas pursuant to RFP 23-057, on December 19, 2023, (hereinafter "Agreement"); and

1. **Time of Performance.** The parties agree that the time of performance for the Agreement shall be extended to April 30, 2025.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
