GOALS:

This project is funded through a CDC grant awarded to the American Mosquito Control Association (AMCA) to support evaluation efforts around surveillance and control of Oropouche virus vectors, primarily Culicoides species. The goal is to generate evaluation-based insights and data that inform public health strategies and practical vector control activities.

POLICIES:

- Intellectual Property: All project findings are intended to be made publicly accessible to support the broader vector control and public health community. AMCA and CDC support full transparency in data sharing, and recipients are

expected to acknowledge AMCA and CDC support in any resulting publications or presentations.

- Expiration of Funds and Extensions: All awarded funds must be spent by September 30, 2025. Any unspent funds must be returned to AMCA. Requests for extensions must be submitted in writing no later than August 30, 2025.

REPORTING REQUIREMENTS AND TIMELINE:

- Monthly Progress Updates: A brief update each month.

- Final Report: A comprehensive final report summarizing methods, findings, challenges, and recommendations must be submitted by September 30, 2025.

- Presentations: Recipients may be requested to share their findings during the 2026 AMCA Annual Meeting, either through oral or poster presentations. Details will be provided in Fall 2025.

AMCA will provide specific reporting templates upon award acceptance.
